

Privacy Policy

The SC Capital Partners Group respects the confidentiality of personal data and recognises the importance of the protection of privacy. The SC Capital Partners Group is committed to comply with the Personal Data Protection Act of Singapore (“PDPA”) and to manage the collection, use and disclosure of personal data in accordance with the PDPA. Unless you directly give us consent to do otherwise, the SC Capital Partners Group will only use your personal data collected via this website or provided to us as described in this Privacy Statement.
