

Daisuke Hiramoto joins SC Capital Partners as Managing Director and Head of Japan

Earlier in his career, he was with Merrill Lynch Japan, having started his career at SMBC in Tokyo.

Mr. Hiramoto holds a Bachelor of Arts in Policy Management Science from Keio University.

SC Capital Partners has been active in the Japanese real estate market since 2010 and has acquired, through its private equity real estate vehicles, over 120 assets. The firm's most recent transactions in Japan include an approximately US\$900 million portfolio of 27 resort hotels, which was acquired from Daiwa House Industry through a consortium with a wholly-owned subsidiary of the Abu Dhabi Investment Authority ("ADIA") and Goldman Sachs Asset Management. SC Capital Partners is also developing a data centre in Osaka, with up to 100MW of secured power, through its vertically integrated data centre operating platform, SC Zeus Data Centers.
